| <ol style="list-style-type: none"> <li>1. Preble County Agricultural Society Membership or a Weekly pass is required to purchase or apply for a camping permit.</li> <li>2. Only one camper unit is permitted at each camp site.</li> <li>3. The campsite will be kept clean and NO dumping of holding tanks on the grounds.</li> <li>4. Wastewater pumping service is available at a nominal fee. (Contact Fairgrounds Office)</li> <li>5. No one under the age of 18 is permitted to stay overnight without adult supervision.</li> <li>6. No Campfires or open burning is permitted.</li> <li>7. One car per site (no pick-up trucks permitted) - Room Permitting</li> <li>8. Hay or Straw is not permitted in any Camping Area.</li> <li>9. Identified Fire Lanes or driveways must be kept open always. (Vehicles parked in Fire Lanes will be towed at the owner's expense)</li> <li>10. The Camping Area curfew is the same as Midway Curfew. (Will be announced nightly)</li> </ol> | <ol style="list-style-type: none"> <li>11. Speed limit of 5 MPH in and around camping area. (Includes Golf Carts and utility vehicles.) – NO ATV/4Wheeler on the grounds. <b>Must be 16 with a valid driver's license to operate a golf cart or utility vehicle.</b></li> <li>12. <b>No Alcohol, abusive drugs, inappropriate language, or improper behavior will be permitted on the fairgrounds or in the camping area.</b></li> <li>13. <b>Violation of any of the camping rules or law violations may result in the loss of the camping privilege. This determination will be made by the Preble County Agricultural Society Board of Directors. Camping privilege loss will require the involved individual to be removed from the camping list for future years. Individuals may reapply and be placed on the active waiting list.</b></li> <li>14. The Preble County Agricultural Society, Preble County Agricultural Society Board of Directors, and the Preble County Commissioners are not responsible for injuries to persons, items, equipment, or accidents on the Preble County Fair Grounds</li> </ol> |
