# 2025 Preble County Market Goat Born and Raised Registration Form

**\*\*Completed Forms Due Sunday, May 4, 2025, at Market Goat Tag/Weigh-In**

### Rules:

- The goat must have been produced by a Preble County goat producer. The project must be born in Preble County. The goat must have been born and raised on the property of the resident producer before selling the animal to the exhibitor.
- Animals may also enter if born and raised by the exhibitor, and they meet the above requirement.
- The goat must have been transferred directly from the Preble County producer to the junior fair exhibitor.
- All goats must have scrapie tags.
- All goats in the Born and Raised Show must also be entered in the Junior Fair Goat Show.
- All goats entering the Born and Raised Show must have an EID ear tag matching their registration form and fair entry.
- Exhibitors can enter up to four goats in the show.
- Preble County Fair personnel reserve the right to verify eligibility.
- All Junior Fair Rules apply.

### To Enter:

- The Breeder must sign the form stating all information provided is true.
- Completed forms, including the Breeder's signature, must be turned in on Sunday, May 4, 2025 Tag-in/Weigh In.
- All goats must enter the Born and Raised Show in the fair entry.
- Exhibitors can enter up to four goats in the show.
- Classes will be determined by weight.
