2026 Preble County Market Lamb Born and Raised Registration Form

****Completed Forms Due at Market Lamb Tag/Weigh-In Sunday, May 3, 2026**

Rules:

- The lamb must have been produced by a Preble County sheep producer. The project must be born in Preble County. The lamb must have been born and raised on the resident producer's property before being sold to the exhibitor.
- Animals may also enter if born and raised by the exhibitor, and they meet the above requirements.
- The lamb must have been transferred directly from the Preble County producer to the junior fair exhibitor.
- All lambs must have scrapie tags.
- All lambs entered in the Born and Raised Show must also be entered in the Junior Fair Sheep Show.
- All lambs entered in the Born and Raised Show must have an EID ear tag matching their registration form and fair entry.
- Exhibitors can enter up to four lambs in the show.
- Preble County Fair personnel reserve the right to verify eligibility.
- All Junior Fair Rules apply.

To Enter:

- The Breeder must sign the form stating that all information provided is true.
- Completed forms, including the Breeder's signature, must be turned in on Sunday, May 3, 2026, at Tag-in/Weigh-In.
- All lambs must enter the Born and Raised Show in the fair entry.
- Exhibitors can enter up to four lambs in the show.
- Classes will be determined by weight.
