



TAGGING YOUR MARKET LAMB OR MARKET GOAT

PREBLE JUNIOR FAIR

MARCH 2025

ACTION STEPS

1. **4-H members** **must** complete their 4-H enrollment on or before April 1, 2025, at 11:59 p.m. Your 4-H market project needs to be enrolled at this time. After your 4-H enrollment is processed (this takes 24 hours), please make your fair entries for your animals.
2. **FFA members** that are taking market projects through their FFA Chapter need to follow the directions below to make a fair entry for your market sheep and/or market goat animal(s).
3. Add each of your market sheep, market goat entries and animals into **Fair Entry** by **11:59 p.m.** on **Thursday, May 1, 2025**. Be sure to complete the required fields.
Pictures of your project are **not** required.
4. Be sure to enter showmanship in Fair Entry.
Showmanship is based on your age as of Jan 1 of the current year.
5. *New this year - If you intend to exhibit in the Born & Raised class, be sure to go ahead and enter your born and raised entry in Fair Entry. Complete the Born & Raised Form and bring it with you to weigh in/tag in.*
6. Bring money (cash or check) for tags & DNA sampling to tagging. \$6 for EID and \$6 for the DNA collection tube (\$12 total).

FORMS NEEDED

Preble County Market Animal Tagging Form - Located on the preblecountyfair.com website.
Complete it and bring form with you to the Tag-In/Weigh-In

Preble County Born & Raised Form – Located on the preblecountyfair.com website. **Complete it and bring form to the Tag-In/Weigh-In if you plan to compete in the Preble County Born & Raised Show and have made the County Born and Raised entry in Fair Entry.**

ENTRY PROCESS FOR 4-H MEMBERS

4-H members should go to <https://oh.4honline.com> and

- Enroll in 4-H unless they are already enrolled for 4-H for 2025. If not, submit your enrollment for processing and then,
- The next day, use the link <https://preble-county.fairentry.com> to go to Fair Entry and log in to your family account/profile using your 4honline credentials and click on the **[green Sign In with 4-H Online Button](#)**
- Click on the Green Register for the Fair Button. Click on the Register an Exhibitor Button. Select an existing person and click Continue
- Continue through the questions to the next page and click on the Continue to Entries button
- Click on the green, add an Entry Button
- Follow the steps below to create a market sheep and or Market Goat entry:

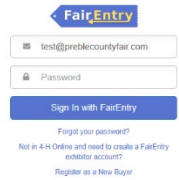


1. Select Junior Sheep or Junior Goat.
2. Select Market Sheep or Market Goat and click on the green Choose Button.
3. Select the correct Class and click the green Continue Button
4. Choose the correct 4-H Club for this entry and click on the green Continue Button.
5. At the next screen, click on the white "Add an Animal Button" to add your animal
6. Click on the green Enter a New Animal Record Button
7. Click on the drop-down box for your animal type and click on Market Sheep or Market Goat.
8. Complete the information for your animal. **All sheep and goats are required to have scrapie tags. Please add your animal's scrapie tag in to the Tag field.** Do not enter any data in the beginning animal weight field. This will be added when your animal is weighed during weigh-ins. **If your animal already has an EID tag, please enter that number, no dashes (beginning with 840) in the RFID Number.** If your animal doesn't have an EID tag, leave the field blank.
9. Click on the Green Create and Add Files Button.
10. Scroll down and click on the green Done with Files Button
11. Click on the green Continue button
12. Select Add another Entry and either add any other market lamb or market goat entries. If finished adding the exhibitor market entries and animals, **please add the sheep and/or goat exhibitor showmanship entry.**
13. If you compete in the County Born and Raised show, add the entry and the existing animal to the entry.
14. At the next screen, you can add another Sheep and/or Goat entry or register another exhibitor (i.e., to make your sibling's entries). **Again, be sure to make your showmanship entry and County Born and Raised entry (if applicable) have been added.**
15. Click on the Continue to Payment Button
16. Click the green Continue Button through the next two screens
17. Click the green Submit Button
18. Click the red Sign Out Button
19. See Tagging Section below and be prepared to bring the requested items to tag/weigh in.

ENTRY PROCESS FOR FFA MEMBERS

FFA members should follow the link <https://preble-county.fairentry.com>



- Go to the Fair Entry exhibitor sign in and either create a new fair entry account or sign in with existing login credentials. (Use your existing credentials if you have already created an account in Fair Entry when you entered your 2025 market beef project in January.)
- Click on the Register an Exhibitor button. If the exhibitor is already listed on the exhibitor screen, select edit. Exhibitors not already in the Fair Entry system will enter as an individual, fill in the New Individual Exhibitor fields, and select Continue. Please continue through the following few screens, add the requested exhibitor information, and select continue. Eventually, you will reach a screen where you choose the Continue to Entries button. From there, you will select the Add an Entry button.
- Follow the steps to create a market Sheep and/or Goat entry.
 1. Select Junior Sheep or Junior Goat
 2. Select Market Sheep or Market Goat and click on the green Choose Button
 3. Select the correct Class and click the green Continue Button
 4. Choose the correct FFA Chapter for this entry and click on the green Continue Button
 5. At the next screen, click on the white "Add an Animal Button" to add your animal
 6. Click on the green Enter a New Animal Record Button
 7. Click on the drop-down box for your animal type and click on Market Sheep or Market Goat.
 8. Complete the information for your animal. **All sheep and goats are required to have scrapie tags. Please add your animal's scrapie tag into the Tag field.** Do not enter any data in the beginning animal weight field. This will be added when your animal is weighed during weigh-ins. **If your animal already has an EID tag, please enter that number, no dashes (beginning with 840) in the RFID Number. Leave the field blank if your animal doesn't have an EID tag.**
 9. Click on the Green Create and Add Files Button.
 10. Scroll down and click on the green Done with Files Button
 11. Click on the green Continue button
 12. Select Add another entry and add any other market lamb or market goat entries. If you have finished adding the exhibitor market entries, add the sheep and/or goat exhibitor showmanship entry.
 13. If you compete in the County Born and Raised show, add the entry and the existing animal to the entry.
 14. At the next screen, you can add another Sheep and/or Goat entry or register another exhibitor (i.e., to make your sibling's entries). **Again, be sure to make your showmanship entry and County Born and Raised entry have been added.**
 15. Click on the Continue to Payment Button
 16. Click the green Continue Button through the following two screens
 17. Click the green Submit Button
 18. Click the red Sign Out Button
 19. See the Tagging Section below and be prepared to bring the requested items to tag/weigh in.

TAGGING

Exhibitors may tag in and show four market Sheep and/or Goat animals.

Market Sheep and/or Goats must be weighed and tagged at the mandatory event at the Preble County Fairgrounds on **Sunday, May 4, 2025, from 1 to 4 p.m.** The weigh-in location will not be in the Expo. The exact location on the fairground is TBA. Please follow the signage that day.

1. Before you arrive at Tag-in, complete the tagging form and bring it with you to the fairgrounds.
2. DNA samples and paperwork will be collected at the weigh-in/tagging.
3. Tags and DNA Tubes will be purchased on the day of weigh-in for \$6 each (EID Tag \$6/DNA Sampling Tube \$6). Be prepared to pay that day.
4. Preble County Born and Raised paperwork for sheep and goats must be turned in on that day.

FINAL REMINDERS

Before you come to Weigh-In/Tag-in, be sure the following has been done:

- Has your market sheep and/or market goats been entered into Fair Entry?
- Have you entered showmanship in Fair Entry for specific species?
- Is your market animal a Preble County Born and Raised?
 - Have you added the County Born and Raised entry to Fair Entry?
 - Have you completed the County Born and Raised paperwork and had the breeder sign off on it?
- Have you gathered the payment for each market animal RFID tag and DNA sample tube? (\$6 for RFID tag and \$6 for DNA tube = \$12 Total. Cash or check payment to PCAS acceptable form of payment)
